Dear Secretary Chiavetta:

Pursuant to Pennsylvania Public Utility Commission's ("Commission") Final Order entered in Docket No. M-2013-2393141 and Secretarial Letter issued on April 8, 2016, Ambit Northeast, LLC ("Ambit") respectfully requests to renew its required level of financial security at the reduced level of 5%.

Ambit has enclosed the following documents for filing with the Commission in support of this letter petition:

- Ambit's gross revenues for the sale of electricity to retail customers in Pennsylvania for the most recent four quarters, attached hereto as Attachment A (CONFIDENTIAL);
- Proof of gross receipts taxes that Ambit has prepaid towards its estimated revenues for the 2017 calendar year, attached hereto as Attachment B (CONFIDENTIAL);
- AEPS compliance data, attached hereto as Attachment C (CONFIDENTIAL); and
- a Tax Letter of Good Standing from the Department of Revenue, attached hereto as Attachment D (CONFIDENTIAL);

Please note that Ambit will submit prepayment of gross receipts taxes for 2018 estimated revenues according to the March, 2018 deadline.

The enclosed documents contain proprietary information of a confidential nature that should not be disclosed publicly. This proprietary information contains sensitive commercial and financial information that, if disclosed to Ambit's competitors, would cause Ambit substantial harm. Therefore, Ambit respectfully requests that the Commission grant confidential treatment of the enclosed attachments. Accordingly, this letter petition includes one version marked public with confidential information expunged and one version marked confidential with un-expunged information.

Ambit has enclosed payment for the requisite filing fees for this letter petition in the amount of \$350.
