The Office of Small Business Advocate (“OSBA”) is in receipt of an electronic subscription notice from the Secretary’s Bureau on February 28, 2018, at 10:17 a.m., for a “PreHear Order” issued in the above-captioned matter. Upon further review, the OSBA found that the document uploaded into the electronic system was in fact “Prehearing Order #3 – Consolidating Complaints, and Establishing Revised Litigation Schedule” dated November 8, 2017. The OSBA was already in receipt of the November 8, 2017, Order, which was received via electronic subscription on November 8, 2017.

On March 1, 2018, the OSBA then received the “Order Admitting Exhibits,” dated February 21, 2018, via interoffice mail. Following the OSBA’s investigation of the above-referenced docket, “C-2017-2576287” docket, the OSBA believes that the November 8, 2017, Order was in fact uploaded in error, as the docket does not reflect the February 21, 2018, Order. It appears that the OSBA received this actual notice a week later than the date this Order was actually entered.


