II. FILING BACKGROUND

On December 27, 2017, Transource Pennsylvania, LLC (“Transource” or the “Company”) filed an application with the Pennsylvania Public Utility Commission (“PUC” or “Commission”) seeking approval of the siting and construction of a portion of a 230kV transmission line and substation associated with the Independence Energy Connection Project (“IEC Project”) in portions of York County.

On March 6, 2018, the OSBA filed an Intervention.

III. IDENTIFICATION TENTATIVE ISSUES

After an initial review of the materials submitted by the Company, the OSBA has identified the following issues:

1. Whether there is a need for the Transource/IEC Project, as proposed; and
2. The potential impact of the proposed Transource/IEC Project on small small business consumers.

The OSBA reserves the right to pursue additional issues as they arise throughout the proceeding.

The OSBA will participate in the case to assure that the interests of small business customers of Appalachian are adequately represented and protected.

IV. SERVICE OF DOCUMENTS

The OSBA requests that all parties serve a hard copy of any document filed in this case upon the OSBA. In addition to hard copies of pleadings, briefs, and exceptions, the OSBA requests hard copies of responses to discovery propounded by the OSBA or any other party.

V. SETTLEMENT


The OSBA notes its willingness to enter into settlement discussions at the appropriate phase of this proceeding.
