Petition of Talen Energy Marketing, LLC To Renew Its Reduced Bonding Requirement Docket No. A-110098

PETITION OF TALEN ENERGY MARKETING, LLC TO RENEW ITS REDUCED BONDING REQUIREMENT

NOW COMES Talen Energy Marketing, LLC ("Talen"), by and through counsel, Debra Raggio, and files the instant Petition to Renew Its Reduced Bonding Requirement ("Petition") and, in support thereof, avers as follows:

- 1. Talen is a licensed electric generation supplier ("EGS") in the Commonwealth of Pennsylvania.
- 2. Talen has been a licensed EGS for more than one year. It was licensed on September 15, 1998 at Docket No. A-110098 and has maintained its license in good standing since that time.<sup>1</sup>
  - 3. Talen is compliant with its current bonding requirements through May 15, 2018.
- 4. By Final Order entered July 24, 2014, the Pennsylvania Public Utility Commission (the "Commission") held that an EGS, following its first year of operations, may petition to have its bonding requirement reduced from 10% to 5% of the EGS's last 12 months of revenue or

\$250,000, whichever is greater. Public Utility Commission Bonding/Security Requirements for Electric Generation Suppliers; Acceptable Security Instruments, Docket No. M-2013-2393141, pp. 17-18, Conclusion and Ordering ¶ 5 (Order entered July 24, 2014) (the "Bond Reduction Order").

- 5. In 2017 Talen filed to have its bonding requirement reduced to 5%. The request for reduced bonding requirement was approved by the commission on March 10, 2017.
- 6. Through this Petition, Talen seeks to maintain its reduced bonding requirement of 5% of its last 12 months of revenue.
- 7. As required by the Bond Reduction Order and pursuant to guidance from the Commission's Bureau of Technical Utility Services, Talen has included as **Appendix A** (CONFIDENTIAL), a spreadsheet that reports Talen's gross receipts from electric generation sales to retail customers in Pennsylvania for the four most-recent quarters (as reflected on its Quarterly Gross Receipts Reports previously filed with the Commission).
- 8. Talen is current with its tax obligations to the Commonwealth of Pennsylvania.

  Talen has requested a Tax Status Letter from the Pennsylvania Department of Revenue and will file such Letter immediately upon receipt.
- 9. After approval of the continued reduction, Talen will make a compliance filing with the bond reflecting the reduced amount.

WHEREFORE, Talen Energy, Marketing LLC respectfully requests that this Honorable Commission, in accord with the Bond Reduction Order at Docket No. M-2013-2393141, grant the

instant Petition and timely approve the reduction to the bonding requirements of Talen Energy Marketing, LLC.
