

PPL Electric Utilities Corporation<sup>1</sup> ("PPL Electric") provides the following:

**I.     INTRODUCTION**

On December 27, 2017, Transource filed with the Pennsylvania Public Utility Commission ("Commission") two Applications for Approval of the Siting and Construction of the 230 kV Transmission Line Associated with the Independent Energy Connection Project in portions of York and Franklin Counties, Pennsylvania ("Applications"). In the Applications, Transource seeks Commission approval to implement a PJM Market Efficiency Project (the "Independence Energy Connection

Project” or “IEC Project”) to alleviate transmission congestion. Under the IEC Project, Transource will construct, own, maintain, and operate two new electric transmission substations in Pennsylvania, as well as the Pennsylvania portions of two new 230kV interstate transmission lines – the Furnace Run-Conastone line (the “IEC-East Line”) and the Rice-Ringgold line (the “IEC-West Line”).

The Applications were referred to the Office of Administrative Law Judge and assigned to administrative Law Judges Elizabeth A. Barnes and Andrew M. Calvelli (“ALJs”). On February 26, 2018, the ALJs issued a Prehearing Conference Order scheduled a prehearing conference for March 13, 2018, with prehearing conference memos due by March 8, 2018. On March 9, 2018, PPL Electric filed a *Nunc Pro Tunc* Petition to Intervene and the instant prehearing memo.
