Pursuant to the "Surface Mining Conservation and Reclamation Act" and the "Clear Streams Law" notice is hereby given that MSD Anthracite Coal Company, 200 East Center Street, Trenton, PA 17981 is applying to renew their Under-Drainage Mining Permit (UMP), #411501 No. 1 Slope, Little Blue Vein from the Department of Environmental Protection, District Mining Operations to conduct standard underground mining operations. There will be no discharge to the receiving stream Wagner Run in the West Branch of the Schuylkill River Watershed. This will be a "dry" mine with no HPOES discharge. The renewal on the No. 1 Slope is located on two point one (2.1) acres of surface support on the existing fifty one point three (51.3) acres subsurface UMP #411501 and in Cass Two, Schuylkill Co. The renewal is located 4500 ft northwest of the village of Call Castle and 1300 ft. north of L.R. #53025, Valley Road in Cass Twp, Schuylkill Co. It is located on the Monroeville Quadrangle from the lower right corner 16.5' north and 3.5' west. The Monroeville Quadrangle, Pa., U.S. Geological Survey 7.5 minute topographic map contains the area described. A copy of the Underground Mine Permit Renewal is available for public inspection at the Department of Environmental Protection Pottsville District Mining Office, 5 West Laurel Blvd., Pottsville, PA 17901. Written comments, or a request for a public hearing or informal conference may be submitted to Mr. Michael J.
