Ashley Mowery v. UGI Utilities Inc.

I come before you as the head of household. I am currently incarcerated and will be for sometime. I am in desperate need of heat for my household. As it states on page 20 of the Initial Decision "Chapter 4 of the public utility code authorizes the commission to establish payment arrangements between and public utility and its customers based on the federal poverty level of the household."

Larry Craynes March 7, 2018 rebuttal is contrary to Judge Cheski's Initial decision. As I've previously stated on page 20 (paragraph 1) states a "payment arrangement is authorized" (paragraph 2) though they need a record of evidence of the correct poverty level to establish this arrangement which is why I've sent in my monthly statement (Exhibit A). All of this falls upon myself, the parties in this matter will not assist me in this debt.

Nowhere in Judge Cheski's initial decision does it say (#9 page 4 of Larry Craynes 3-7-18 rebuttal) that a payment arrangement is not considered appropriate, irregardless of the circumstances that I have been put through.

In response to Larry Craynes March 7, 2018 rebuttal of

page 4, #9; I have no problem with paying what is due though I will have to do so through a payment plan. As already known I Ashley Mowery (home owner) did not have anything to do with this theft of services/meater tampering fore I was incarcerated and only had the house for one month prior to being. I already have to bear the burden of \$4,573.41 for others actions and behaviors all I am asking for is a payment plan to make that possible.

There hasn't been anybody residing in the house since July 2017 due to the fact that there is not available heat for any tenants to live during the winter. Which becomes such a hardship on me due to the fact that I am not able to make any 'decent' profits to pay toward this debt.

To address and create a Federal Poverty level on file I am sending you my monthly statement (exhibit A), which is also the same income every month for me of each year. The only person I am able to take care of is myself, therefore I only take care of one person. I would like to create a payment arrangement to begin paying on the outstanding balance, for I am entitled to this through Chapter 14 of P.U.C.

I would greatly appreciate if we could come to a payment arrangement in the near future.
