Jeffrey Shilling ("Respondent") has paid, in full, his outstanding assessment balance for the July 1, 2016 to June 30, 2017 Fiscal Year ("2016-2017 Fiscal Year") and an agreed-upon civil penalty to resolve the above-docketed complaint without litigation.
