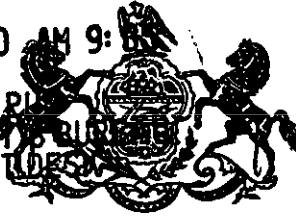

To whom it may concern,

On 5/4/17, I received a letter that I need to have my insurer file the appropriate paperwork, form E, for bodily injury and property damage liability to the PUC or I will be suspended. On 5/9/17 form E was filed by Erie Insurance using the NOR system and approval was received. On 5/17/17, I received another letter that a complaint has been filed against me which stated that either I file an answer in compliance with the attached notice AND/OR causes its insurer to file evidence of insurance with this Commission with 20 days of the date of service of this complaint (5/17/17). On 5/31/17, Erie Insurance again filed form E in compliance with the letter using the NOR system and received approval.

On June 2nd, 2017, I received a letter from the PUC stating they had received evidence of Liability insurance coverage. So I thought everything was resolved and took no further action.

On Sept 12th, 2017 I received another letter stating I needed to pay a \$500 fine because "The Complaint was served on the Respondent on May 25th, 2017. To date, more than twenty (20) days later, Respondent has failed to file an answer to the Complaint. On May 31, 2017, the Respondent's insurer filed evidence of insurance effective on April 13th, 2017; however, Respondent has failed to pay the fine."

Can you please review and possible overturn this fine due to the circumstances?
