**PHILADELPHIA GAS WORKS’
MOTION TO DISMISS ANY FUTHER
EXCEPTIONS AS UNTIMELY**

The Philadelphia Gas Works (PGW) hereby files its Motion to Dismiss Any Further Exceptions as Untimely.

I. History of the proceedings relevant to the Motion

By Secretarial Letter dated December 20, 2017, the Commission issued the Initial Decision of Administrative Law Judge Christopher P. Pell in this matter. Exceptions were due within twenty days of that letter (*i.e.*, January 9, 2018). Reply Exceptions were due within ten days after the date that Exceptions were due (*i.e.*, January 19, 2018).

On January 9, 2018, the Complainant filed a Petition for Additional Time to File Exceptions. The Complainant also filed Partial Exceptions and Amended Complaint, a 36 page document that includes exhibits.

On January 19, 2018, PGW filed a Reply to Complainant’s Exceptions. PGW also filed a Reply to the Complainant’s Petition for Additional Time to File Exceptions, objecting to the petition.

On February 9, 2018, the Complainant filed “Complainant’s Second Request for Additional Time to Fully File Her Exceptions to the Alleged Judge Pell’s Illegal Decisions.”

On February 20, 2018, the Complainant filed her response to PGW’s reply to her

petition for additional time, a ten page document that includes exhibits.

On February 22, 2018, Complainant filed "Complainant's Fourth Request for Additional Time to Fully File Her Exceptions."

On March 2, 2018, Complainant filed "Complainant's Fifth Request for Additional Time to Fully File Her Exceptions," a 20 page document that includes exhibits.

By Secretarial Letter dated March 12, 2018, the Commission granted the Complainant's request for extended time to file exceptions. Exceptions were due within ten days of that letter (*i.e.*, March 22, 2018). Reply Exceptions were due within ten days after the date that Exceptions were due (*i.e.*, April 2, 2018).

II. Motion to Dismiss Any Further Exceptions as Untimely

The deadline for the Complainant's extension of time has passed and the Complainant has failed to file any additional exceptions in this matter, see Attachment "A". While it is understood that the Commission endeavors to be lenient with *pro se* complainants, this matter has reached a stage where leniency has begun to push up against the fundamental fairness owed to both parties in a matter. Compliance with a deadline does not require any legal training or specialized knowledge. In this case particularly, deadlines have been set and adhered to. In his Initial Decision, Judge Pell rejected PGW's proposed Exhibits 10 and 11 because the deadline for submission was June 29, 2017 and, despite being dated June 29, 2017, they were not received by the Court until June 30, 2017. The Complainant asked for an extension of time, was granted an extension of time, was made aware of the deadline for that extension, and has failed to meet it.

Wherefore, PGW respectfully requests that this Commission dismiss any further exceptions filed by the Complainant as untimely.
