Dear Secretary Chiavetta:

On Feb 27, 2018 in a meeting before Judge Angela Jones an agreement was reached to settle the outstanding issues on our account 02235-01100 as attached to this letter. The agreed balance due was \$13,476.19.

Since the date of this agreement we have received a Payment Agreement Confirmation in the amount of \$18,817.12 as attached that is not in accordance with the agreement reached. The payment confirmation requests a downpayment of \$5340.93 which is not correct. The settlement agreement only requires 7 monthly payments of \$1925.17 beginning in April 2018. I emailed this information to Shawanee Lee (attached) and also contacted Adrian today at Peco Electric and she refused to correct the error, and told me to contact the PUC.

Therefore we are not in agreement with this settlement until such time as Peco corrects their records and billing to match what they agreed to at the settlement and in writing as attached.

Pursuant to our conversation at the hearing before Administrative Law Judge Angela T. Jones, this letter confirms the resolution of your Public Utility Commission (PUC) complaint. As the parties desire to amicably resolve the dispute without the need for further litigation, PECO Energy has resolved your formal complaint as follows:

- 1) You have agreed to pay your March bill in full by the payment due date of March 5, 2018.
- 2) PECO will apply the \$3,160.00 deposit the company has on hand to your account.
- 3) PECO will process a seven (7) month payment agreement on a \$13,476.19 balance. Under the agreement, you are to pay \$1,925.17 per month plus your current bill beginning with the bill due in April 2018.

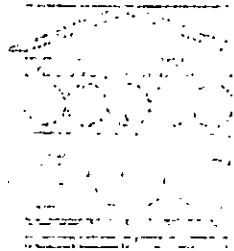
