3. That the formal complaint filed by the Bureau of Investigation and Enforcement against Pine Roe Natural Gas Co., Inc on January 4, 2017 at Docket Number C-2017-2582760 is hereby dismissed.

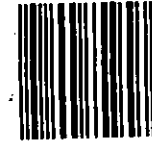
