**RESPONDENT PPL ELECTRIC UTILITIES CORPORATION'S  
CERTIFICATE OF COMPLETION**

**AND NOW**, comes Respondent PPL Electric Utilities Corporation (“Respondent PPL”), by and through its counsel, Gross McGinley, LLP, and submits the instant Certificate of Completion as follows:

1. On or about March 1, 2018, the Pennsylvania Public Utility Commission (the “Commission”) issued an Opinion and Order, which required Respondent PPL to restore the property of Complainant John J. Horwith, Jr. (“Complainant”) by “fill[ing] in the holes that it created when it removed the trees within its right-of-way and to move the wood to a more suitable location on the Complainant’s property.” *See* 03/01/18 Opinion and Order at p. 16.

2. The Commission further directed Respondent PPL to file a Certificate of Completion upon completion of Complainant’s property restoration. *See id.* at p. 19, ¶ 5.

3. Consistent with the Commission’s Order and Opinion, on March 15, 2018, Respondent PPL contacted Complainant for the purpose of scheduling the aforementioned property restoration.

4. At the time of that telephone call, Complainant informed Respondent PPL's Forester that he did not want Respondent PPL to move any wood on his property.

5. In addition, at the time of that telephone call, the property restoration was scheduled for March 27, 2018.

6. On the morning of March 27, 2018, Respondent PPL again contacted Complainant to notify him that the property restoration would begin that day at 8:30 a.m.

7. At the time of that telephone call, Complainant informed Respondent PPL that he would permit Respondent PPL to fill the holes on his property, but that he would not agree to allow Respondent PPL to move any wood on his property.

8. On March 27, 2018, Respondent PPL filled the holes on Complainant's property consistent with the Commission's Opinion and Order. True and correct copies of before and after photographs of the two holes are attached hereto as **Exhibit "A,"** and **Exhibit "B,"** respectively.

9. However, Complainant would not permit Respondent PPL to move any wood on his property, despite the Commission's Opinion and Order which directed Respondent PPL to do so. To the contrary, Complainant indicated that he would move the wood himself.

10. In light of the aforementioned, Respondent PPL hereby avers that it has fully complied with its responsibilities as set forth in the Commission's March 1, 2018 Opinion and Order.

11. As such, Respondent PPL respectfully requests that the docket for this matter be marked closed.

**WHEREFORE**, Respondent PPL respectfully requests that the docket for this matter be marked closed.
