DICK D RAMOS, OWNER, OF DXT TRANSPORTATION INC., HEREBY REQUESTS A RECONSIDERATION OF THE DISMISSAL FOR NON-COMPLIANCE FOR A-2017-2629426.

- 1) THE RESPONDENT, DICK D RAMOS, HEREBY STATES THAT HE RECEIVED A NOTIFICATION OF COMPLIANCE FROM THE PENNSYLVANIA PUBLIC UTILITY COMMISSION, ON OR ABOUT JANUARY 2, 2018. THE LETTER REQUESTED THE REQUIRED FILINGS OF INSURANCE COVERAGE AND AN ACCEPTABLE TARIFF.
- 2) MR. RAMOS CONTACTED HIS INSURANCE CARRIER TO REQUEST SUBMISSION OF THE REQUIRED INSURANCE DOCUMENTS. MR. RAMOS THEN PROCEEDED TO REVIEW THE REQUEST FOR A TARIFF AND SUBMITTED THE TARIFF TO THE PENNSYLVANIA PUBLIC UTILITY COMMISSION.
- 3) MR. RAMOS WAS INFORMED BY THE COMMISSION, BY LETTER DATED MARCH 16, 2018, THAT THERE WAS DISMISSAL OF HIS APPLICATION DUE TO NON COMPLIANCE OF FILING AN ACCEPTABLE TARIFF.
- 4) MR. RAMOS HAS REVIEWED THE FILE, AND IS HEREBY SUBMITTING A (CURRENT) TARIFF TO BE FILED WITH THE COMMISSION.
- 5) THEREFORE, MR. RAMOS IS HEREBY REQUESTING THE RECONSIDERATION FOR DISMISSAL OF A-2017-2629426.
