Q.1 Reference First Amendment to Street Light System Purchase and Sale Agreement - The submitted document has no effective date, please resubmit document with an effective date indicated.

A.1 The First Amendment did not include the effective date as filed because it will not be effective unless and until (i) either the Pennsylvania Public Utility Commission ("PUC") has provided written approval authorizing this First Amendment, or, by the passage of time, the PUC is deemed to have provided such approval and (ii) subsequently, Township has received a written notice of the PUC's approval from PPL Electric. The date of such written notice from PPL Electric to the Township shall be the "Effective Date" of this First Amendment, and at this time is unknown. Should the PUC not approve of this First Amendment, then this First Amendment shall deemed null and void.

As PPL Electric cannot offer the effective date at this time, the Company submits that it will file a copy of the First Amendment, with the effective date, within 10 days of the effective date, if approved by the PUC.
