


The Initial Hearing in this formal complaint has been set for April 17-18, 2018. By Prehearing Order issued on September 7, 2017, Administrative Law Judge Heep ordered that: "**ON OR BEFORE** April 3, 2018, Complainant and Counsel for PECO are directed to provide one another with copies of all exhibits and statements to be presented at the hearing."

We attest that we delivered evidence to PECO on April 3rd, as signed by PECO employee Andre Smith. We also attest that we did **NOT** receive any evidence from PECO **ON OR BEFORE** April 3, 2018. We received on April 4, 2018 a FedEx package from 2301 Market Street. Enclosed is a copy of the packing slip and a tracking form from FedEx showing the dates of pick up from PECO and delivery. It remains unopen because PECO did not comply with the order, as stated supra. We therefore ask that the contents of said packet be disallowed to be submitted as evidence at the Initial Hearing on April 17-18, 2018.

By the same Prehearing Order, Judge Heep ordered that "**ON OR BEFORE** February 20, 2018, any party wishing to present factual testimony of any person other than the Complainant must provide to the other party the name and business address of that person and a written summary of the expected testimony of that person." In retrospect, we realized now and further attest that PECO did **NOT** provide **ON OR BEFORE** February 20, 2018 said evidence. PECO delivered said material **AFTER** February 20, 2018. We ask that the factual testimony of persons and their written summaries be disallowed for failure to comply with said order.
