On behalf of TVC Albany, Inc. d/b/a FirstLight Fiber (“FirstLight”), enclosed for filing are an original and three (3) copies of FirstLight’s initial compliance tariffs for the provision of resold and facilities-based local exchange services, designated as Telephone Pa. P.U.C. Tariff No. 1 (Competitive Local Exchange Carrier Service); switched access services, designated as Telephone Pa. P.U.C. - Table of Contents, Original Page 2: Deleted Section 3.1.2, as it is not included in the tariff.

- Section 4.2.4 (3), Original Page 10: Third row text after “new” has been realigned.
