**RE: Stream Energy Pennsylvania, LLC's Request for Continuation of 5% Reduction in Security Requirements; Docket No. A-2010-2181867**

Dear Secretary Chiavetta:

Pursuant to the Secretarial Letter dated September 4, 2015, Stream Energy Pennsylvania, LLC ("Stream Energy") received authority to reduce its security with the Pennsylvania Public Utility Commission from 10% to 5% of Stream Energy's most recent twelve months of revenue. The Commission granted Stream Energy continuations of that 5% reduction in security requirements pursuant to its August 4, 2016 and July 13, 2017 Secretarial Letters. Stream Energy files this Letter Petition to renew its security at the reduced level of 5% based on its most recent twelve months of revenue.

In support of this Letter Petition, please find the following information and documentation:

- 1) A spreadsheet of Stream Energy's gross receipts in Pennsylvania for the four most-recent quarters (from 2Q-2017 through 1Q-2018) on a monthly basis attached hereto as Appendix A (**CONFIDENTIAL**);
- 2) Stream Energy's Tax Status Letter from the Department of Revenue attached hereto as Appendix B (**CONFIDENTIAL**) to evidence that Stream Energy is current with its tax liabilities to the Commonwealth of Pennsylvania;
- 3) A copy of Stream Energy's form REV-423 Specialty Tax Estimated Payment Form attached as Appendix C (**CONFIDENTIAL**);
- 4) A letter from the AEPS Administrator confirming Stream Energy's compliance with AEPS requirements attached hereto as Appendix D (**CONFIDENTIAL**); and
- 5) Check #545855 in the amount of \$350.00 for the required fee.

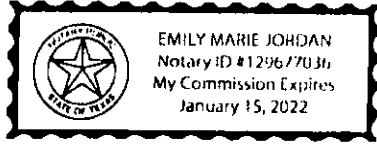
