1998 Mack RD 688 Roll-off ; 2006 Mack CV 713 Roll-off ; 2006 Ford F-350 ; Misc Spare parts.

Seller warrants that(1)the Seller is the legal owner of the equipment; (2) the equipment is free and clear from all liens and encumbrances; (3)the Seller has the right to sell the equipment; and (4)the Seller will warrant and defend the title of the Equipment against any and all claims and demands of all persons.
