To Whom It May Concern:

This letter is to inform you of the reason for the change in insurance for Pro-Transportation.

The reason for the insurance change is due to Pro-Transportation having a customer that requested that Pro-Transportation increase the cargo insurance from \$250,000 up to \$500,000. Progressive insurance does not offer \$500,000 cargo insurance. Therefore, Pro-Transportation had to get insurance from another insurance company. On March 9, 2018 the cargo insurance was switched to Atlantic Specialty Insurance Company. On March 9, 2018 the cargo insurance was cancelled with Progressive Insurance. At no time did Pro-Transportation go without cargo insurance, as you can see with the attached papers.

Be advised that when this replacement cargo policy was issued, the carrier initially failed to file the Form "H" at the original inception date but did make that filing based upon my request on 4/23/18. That document did show proof of coverage with an inception date of 3/9/18, the same date that the Progressive cargo coverage was cancelled.

The original Form "H" was rejected because our Motor Carrier address was incorrect. Subsequently a revised Form H was issued that included my correct address (Enclosed is a copy of that document).

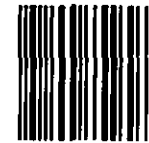
