
Dear Ms. Giesler:

Ordering Paragraph No. 15 of the Pennsylvania Public Utility Commission's Order in *Tanya J. McCloskey v. Hidden Valley Utility Services, L.P.*, Docket Nos. C-2014-2447138 and C-2014-2447169 (Opinion and Order on Reconsideration entered May 3, 2018), requires Hidden Valley Utility Services, L.P. ("Hidden Valley") to "execute appropriate authorization forms permitting its electric provider, Pennsylvania Electric Company, to continue providing monthly billing and payment information for all [Hidden Valley] accounts to the Office of Consumer Advocate until the requirements under Ordering Paragraph No. 28 are satisfied." Ordering Paragraph No. 28 provides that the proceedings in that case are to be closed when certain conditions are satisfied.

Hidden Valley hereby grants authority to Pennsylvania Electric Company to disclose account information to the Office of Consumer Advocate ("OCA"). Specifically, Hidden Valley hereby authorizes Pennsylvania Electric Company to provide billing and payment information for all accounts listed below to the OCA, effective immediately, until the proceedings in *Tanya J. McCloskey v. Hidden Valley Utility Services, L.P.*, are closed. The parties will notify Pennsylvania Electric Company that the proceedings have been closed and that this authorization has expired and is revoked.
