PUBLIC STATEMENT OF THE
OFFICE OF CONSUMER ADVOCATE
PURSUANT TO 71 P.S. SECTION 309-4(e)

Act 161 of the Pennsylvania General Assembly, 71 P.S. Section 309-2, as enacted July 9, 1976, authorizes the Consumer Advocate to represent the interests of consumers before the Pennsylvania Public Utility Commission (Commission). In accordance with Act 161, and for the following reasons, the Acting Consumer Advocate determined to file an Intervention and participate in proceedings before the Commission involving the Petition of Transource Pennsylvania, LLC (Transource or the Company)

On May 15, 2018, Transource filed its Zoning Petition with the Pennsylvania Public Utility Commission. In its Zoning Application, Transource seeks Commission approval of the siting and construction for a building to shelter control equipment (“Control Equipment Building”) at the proposed Furnace Run Substation in York County, Pennsylvania. Zoning Petition at 1. The proposed Furnace Run Substation is part of the Independence Energy Connection Project, which was approved by PJM Interconnection, L.L.C. to address certain transmission congestion constraints in Pennsylvania, Maryland, West Virginia, and Virginia. Zoning Petition at 1.

The OCA has determined to intervene and participate in these proceedings to ensure that the “Zoning Petition” is approved only if it meets all legal requirements of the Public Utility Code, applicable Commission rules and regulations, and Pennsylvania law, as well as to ensure that the interest of Pennsylvania ratepayers are protected in this proceeding.
