Dear Ms. Chiavetta:

We are responding to your notice regarding subject item. A copy of the Data Request is enclosed.

Three items are involved in our response.

First, the Registration for 2016 was not submitted. The Registration for 2016 is enclosed with the Registration Form and the annual fee of \$250.00 via check no. 3904. Our office was moved to Lemont, PA in the March- April time period and the Act 127 Registration Form and Fee were misplaced.

Second, during 2016 the Class 1 gathering lines were extended from 4.3 miles in 2015 to 6.4 miles in 2016. Included with the mileage change in 2016 was a short distance of 0.1 miles to make 0.3 miles for Class 2 gathering lines for 2016 from 0.2 miles in 2015.

Third, for the Hazardous Liquid Intrastate Lines mileage change from 2015 to 2017 reports is due to a mis-interpretation error of natural gas (non-liquid) lines versus crude oil (hazardous liquid) lines. The crude oil lines are for those lines from 6 conventional oil-gas wells to crude oil holding tanks at each well site. These are the only hazardous liquid lines operated by our company.

The 2017 Act 127 Registration Form is unchanged from the 2016 form (enclosed).

I, John Exley, hereby state that the facts set forth are true and correct to the best of my knowledge, information and belief, and that I expect to be able to prove the same at a hearing held in this matter. I understand that the statements herein are made subject to penalties of 18 Pa. C.S.# 4904 (relating to unsworn falsification to authorities).


