Pursuant to the Commission's *Interim Guidelines Regarding Notification by an Electric Generation Supplier of Operational Changes Affecting Customer Service and Contracts*, adopted on August 13, 1998 in Docket No. M-00960890F.0013, the purpose of this letter is to advise the Pennsylvania Public Utility Commission ("PUC" or "Commission") that Mint Energy, LLC ("Mint") is transitioning [REDACTED]

[REDACTED] Specifically, Mint will assign approximately [REDACTED] contracts for the provision of electric generation service to Pennsylvania retail customers. Mint was licensed by the PUC in Docket No. A-2010-2199478, and [REDACTED].
