Lastly, I am at an extreme disadvantage due to my inability to use Computers. I am still searching for someone who has time and Capability - scan, email, fax, for me. I am not able to do things as timely, disabled by electronics. It is a financial hardship to use overnight mailing.

I would appreciate your understanding of my circumstances and an ongoing accommodation throughout this process.

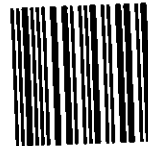
