
PLEASE REVIEW THIS COMPLAINT.

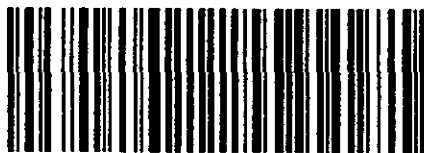

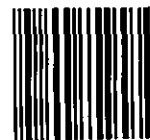
