



**PREHEARING CONFERENCE MEMORANDUM OF
DUQUESNE LIGHT COMPANY**

TO ADMINISTRATIVE LAW JUDGE CONRAD A. JOHNSON

Pursuant to 52 Pa. Code § 5.224(c) and the April 2, 2018 Prehearing Conference Order, issued by Administrative Law Judge, Conrad A. Johnson (the “ALJ”), Duquesne Light Company (“Duquesne Light” or the “Company”) hereby submits this Prehearing Conference Memorandum.

I. SERVICE OF DOCUMENTS

II. PROCEDURAL HISTORY

3. This proceeding was initiated on March 23, 2018, when Duquesne Light filed and served the Application of Duquesne Light Company for Approval of the Siting and Construction of the 138 kV Transmission Lines Associated with the Universal-Plum Project in Penn Hills, Monroeville, and Plum Borough, Allegheny County, Pennsylvania, which was docketed at Docket No. A-2018-3000708 (“Full Siting Application”).

4. Together with the Full Siting Application, Duquesne Light filed and served the following Attachments in support of the Full Siting Application:

5. Furthermore, in support of the Full Siting Application, Duquesne Light submitted the written direct testimony of Jason A. Harchick (Duquesne Light St. No. 1), Aimee Kay (Duquesne Light St. No. 2), Meenah Shyu (Duquesne Light St. No. 3) and Mark E. Hummel (Duquesne Light St. No. 4).

6. Simultaneous therewith, Duquesne Light also filed ten (10) Condemnation Applications related to new rights-of-way and easements that were needed from certain property owners, which were docketed at Docket Nos. A-2018-3000732, A-2018-3000733, A-2018-3000743, A-2018-3000747, A-2018-3000754, A-2018-3000755, A-2018-3000756, A-2018-3000766, A-2018-3000768, and A-2018-3000769 (“Condemnation Applications”). Each Condemnation Application also included the direct testimony of Mark E. Hummel (Duquesne Light St. No. 1).

7. Collectively, the above-referenced materials constitute the “Universal-Plum Project Applications.”

8. On March 30, 2018, the Pennsylvania Public Utility Commission (“Commission”) issued a Secretarial Letter stating that notice of the Universal-Plum Project Applications would

be published in the Pennsylvania Bulletin on April 14, 2018, and that the deadline for formal protests and petitions to intervene was June 7, 2018.

9. On April 2, 2018, a Hearing Notice was issued scheduling an Initial Prehearing Conference on June 13, 2018, at 10:00 a.m. in the 2nd Floor Hearing Room, Piatt Place, Suite 220, 301 Fifth Avenue, Pittsburgh, PA 15222.

10. On April 2, 2018, the Administrative Law Judge Conrad A. Johnson issued a Prehearing Conference Order.

11. Notice of the Universal-Plum Project Applications was published in the April 14, 2018 edition of the *Pennsylvania Bulletin*.

12. On May 23, 2018, counsel for Maria Paolombo Aiello, Antoinette Cardinale and Anna Louise Palmobo, condemnees subject to the Condemnation Application at Docket No. A-2018-3000747, served a Praecipe for Appearance and Prehearing Memorandum.

III. ISSUES

13. In the Full Siting Application, Duquesne Light has requested Commission approval to site and construct approximately 4.21 miles of overhead 138 kV transmission lines located in Penn Hills, Monroeville, and Plum Borough, Allegheny County, Pennsylvania, associated with the Universal-Plum Project.

14. Duquesne Light has demonstrated that the proposed route for the overhead transmission line was selected after an extensive, multi-faceted analysis to determine the overall best route for the proposed Universal-Plum Project in accordance with the Commission's regulations at 52 Pa. Code § 57.72(c). Duquesne Light has demonstrated that, overall, the proposed route will have significantly less cumulative social, environmental, constructability, and financial impacts than the alternative route.

15. The proposed Universal-Plum Project will be constructed and operated in compliance with applicable statutes and regulations.

21. Duquesne Light does not believe, at this time, that any modifications to the standard timelines for discovery set forth in the Commission's regulations are necessary or appropriate.

23. If this proceeding is not contested, Duquesne Light respectfully requests that the Commission issue an order approving the Universal Plum Project Application.


VII. PUBLIC INPUT HEARINGS
