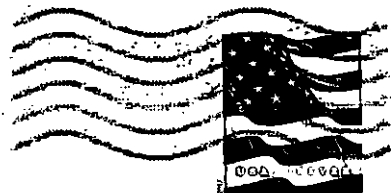

PENNSYLVANIA PUBLIC UTILITY COMMISSION NOTICE
Application of Aspen Energy Corporation For Approval To Offer, Render, or Furnish Natural Gas Services as a Supplier, Aggregator, or Marketer/Broker Engaged In The Business Of Supplying Natural Gas Supply Services, To The Public In The Commonwealth Of Pennsylvania.
Aspen Energy Corporation will be filing an application with the Pennsylvania Public Utility Commission ("PUC") for a license to provide natural gas supply services as (1) a supplier or aggregator of natural gas, and (2) a broker/marketer engaged in the business of providing natural gas services. **Aspen Energy Corporation** proposes to sell natural gas and related services in Columbia Gas, National Fuel Gas, PECO, Peoples - Equitable, Peoples Natural Gas, Peoples Gas Company, Philadelphia Gas Works, UGI, UGI Central Penn, UGI Penn Natural, Valley Energy under the provisions of the new Natural Gas Choice and Competition Act.
The PUC may consider this application without a hearing. Protests directed to the technical or financial fitness of **Aspen Energy Corporation** may be filed within 15 days of the date of this notice with the Secretary of the PUC, 400 North Street, Harrisburg, PA 17120.
