**Re: Notice of Assignment of National Choice Energy, LLC Customer Contracts to Astral Energy, LLC

Dear Secretary Chiavetta,

Pursuant to the *Commission's Interim Guidelines Regarding Notification by an Electric Generation Supplier of Operational Changes Affecting Customer Service and Contracts* (Docket No. M-00960890F0013, please accept this joint letter as notice by National Choice Energy, LLC, (Electric Generation Supplier License No. A-2017-2597692) ("NCE"), and Astral Energy, LLC (Electric Generation Supplier License No. A-2014-2439632) ("Astral"), that NCE will assign its Pennsylvania customer contracts to Astral. Astral is licensed to serve customers in all of the Electric Distribution Company territories where the assigned customers are located.

The assignment will take effect on or about July 19, 2018, and Astral will begin serving NCE's Pennsylvania customers at that time. After the assignment, NCE will have no customers in Pennsylvania. NCE will remain in active operation to serve its load at least until such time as all customers are transitioned to Astral, and thereafter will determine whether it will continue to operate in Pennsylvania. As such, this letter should not be considered a notice of cessation pursuant to 52 Pa. Code § 54.41. Any such filing will be separately made by NCE if and when appropriate.

The assignment transaction will be seamless for customers. Astral will assume NCE's contracts as they stand. Accordingly, customers will experience no change in terms or conditions for the duration of their contracts. NCE does not apply fees for customers who leave prior to the end of their contract, and Astral will honor this provision as well.

As required by the aforementioned *Interim Guidelines*, NCE and Astral have sent the enclosed materials to customers to notify them of the upcoming transition of their accounts. The materials


include a joint letter to customers from NCE and Astral, and a timeline of what customers can expect to happen next.

NCE and Astral customer service agents have been trained to talk to customers as the transition occurs, and to explain what the transition means for the customers. NCE and Astral are confident that this assignment transaction will be seamless for customers.


Both NCE and Astral are compliant with their Alternative Energy Portfolio Standards obligations and compliant with all Commission assessments. Enclosed herewith are **Confidential** copies of Astral and NCE's Quarterly Reports of Gross Receipts for the last four quarters. Astral and NCE respectfully request that these reports be filed under seal, because they contain confidential business and financial information about the company's that could cause competitive harm if publicly disclosed.



We at Astral Energy are pleased to have you as a customer. Here is more information about the transition process:

- National Choice Energy and Astral Energy have provided notice of the assignment to the Pennsylvania Public Utility Commission.
- The assignment of customer contracts from National Choice Energy to Astral Energy will become effective on July 19, 2018.
- Astral Energy will be notifying your Electric Distribution Company that we will become your new electricity supplier.
- Your Electric Distribution Company will continue to read your meter, issue your bill, and respond to emergencies and outages.


