We are counsel for Suez Water Pennsylvania Inc. ("Suez"). We have been advised by Mediator Lehman that Suez has not answered the above referenced Complaint of MaryLee Warren at C-2018-3001067. Upon review of the Complaint at C-2018-3001067, it is apparent that it is the same Complaint of Ms. Warren docketed at C-2018-3001083. We filed an Answer, on April 27, 2018, to Ms. Warren's Complaint at C-2018-3001083 along with a Motion for Judgment on the Pleadings. The Motion for Judgment on the Pleadings is pending before Deputy Chief Administrative Law Judge Cheskis. As the two dockets involve the same Complaint, we believe it would be appropriate for Judge Cheskis to address both Complaints in resolution of the Motion already pending before him at C-2018-3001083 without the need for the filing of additional pleadings by Suez at C-2018-3001067. Ms. Warren is not a customer of Suez. Ms. Warren resides within a mobile home park known as Harborton Place, Middletown, Pennsylvania, that is apparently owned and/or operated by Kodiak Property Management, Cheyenne, Wyoming, with water and wastewater service billed to Ms. Warren by ABT Water Management, Inc., Beloit, Wisconsin. Ms. Warren did not answer the Motion for Judgment on the Pleadings.


