On June 1, 2018, Pennsylvania-American Water Company ("PAWC") filed an application with the Pennsylvania Public Utility Commission ("PUC") to acquire the wastewater system of the Township of Sadsbury ("Township") and to begin wastewater service in the proposed service territory currently served by the Township. The application was accepted for filing by the PUC on June 19, 2018. By PUC Secretarial Letter dated June 19, 2018, PAWC was directed to serve a copy of the application on: (i) "each city, borough, town, township, county and related planning office which is included in whole or in part, in the proposed service area"; (ii) "[a] water or wastewater utility, municipal corporation or authority which provides water or wastewater collection, treatment and disposal service to the public and whose service area abuts the service area proposed in the application"; and, (iii) "the Department of Environmental Protection's appropriate regional office."
