Your Honor:

On June 25, 2018, PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) filed a Motion to Dismiss Objections and Compel Responses to Discovery Propounded on Kathleen R. Anthony (“Complainant”) – Set I, in the above-referenced proceeding. Under the Pennsylvania Public Utility Commission’s (“Commission”) regulations, the Complainant’s Answer to the Motion would be due “within 5 days of service of the motion absent good cause.” 52 Pa. Code § 5.342(g)(1).

Since filing the Motion, the Complainant and counsel for PPL Electric exchanged email correspondence. The Complainant indicated that she is out of state at a conference for the rest of the week and, therefore, is unable to prepare an Answer to the Motion within the 5-day period.

Accordingly, the parties have agreed to request an extension of the Answer’s due date until July 6, 2018. This extension is reasonable given the Complainant’s status. It also will facilitate the parties’ attempts to resolve the Complainant’s objections informally without the need for a ruling on the Motion to Compel. Therefore, good cause exists to extend the Answer’s due date.

For these reasons, to the extent that the Complainant ultimately files an Answer to the Motion to Compel, PPL Electric respectfully requests that Your Honor consider the Complainant’s Answer as timely if it is filed on or before July 6, 2018.
