Dear Secretary Chiavetta:

On June 1, 2018, a Secretarial Letter was issued with the Initial Decision dismissing the Formal Complaint of Andrew C. Menichino for Caravan II, LLC. The Secretarial Letter provided the parties 20 days from the date of the letter to file exceptions, or June 21, 2018, and stated that any replies to exceptions were to be filed within 10 days thereafter, or July 1, 2018. Mr. Menichino submitted a document to the Secretary's Bureau on behalf of Caravan II, LLC, titled as a "Refiling of Complaint" and consists of a page titled "Amendment to Complaint," a new Formal Complaint dated June 25, 2018, a copy of the Commission's Prehearing Order issued March 19, 2018, and a Certificate of Service stating that the "Proposed Motion" was be served on counsel for Pennsylvania Power Company ("Penn Power"). This document has been deemed Exceptions. On June 27, 2016, Penn Power received a copy of the "Refiling of Complaint" from Mr. Menichino. Penn Power notes that the "Refiling of Complaint" was filed by Mr. Menichino rather than the attorney for Caravan II, LLC.

In light of the late filing and receipt of the exceptions, Penelec respectfully requests that it be granted an extension until July 10, 2018 to file its reply to Mr. Menichino's exceptions. Thank you for your attention and consideration in this regard.
