Dear Secretary Chiavetta:

In accordance with 52 Pa. Code § 54.34 and 52 Pa. Code § 62.105, the NRG retail affiliates, including Energy Plus Holdings LLC (A-2009-2139745), Green Mountain Energy Company (A-2011-2229050, A-2017-2583732), Independence Energy Group LLC (A-2011-226337, A-2013-2396449), Reliant Energy Northeast LLC (A-2010-2192350, A-2015-2478293) and XOOM Energy Pennsylvania, LLC (A-2012-2283821, A-2012-2283967) provide the following updates to their licenses:

- Effective June 1, 2018, NRG Retail LLC ("NRG") acquired 100% of the membership interest in XOOM Energy Global Holdings, LLC ("Global Holdings"). Global Holdings holds 100% membership interest in XOOM Energy, LLC which holds 100% membership interest in XOOM Energy Pennsylvania, LLC ("XOOM Energy"). XOOM Energy will retain its licenses and all customers currently served by XOOM Energy will continue to be served by XOOM Energy. XOOM Energy will become another NRG retail subsidiary, similar to – and affiliated with – the other NRG retail affiliates noted above.
- 2. XOOM Energy is now affiliated with two entities with a franchised service area within the Commonwealth of Pennsylvania, NRG Energy Center Harrisburg LLC and NRG Energy Center Pittsburgh LLC which are owned by NRG.

- 3. XOOM Energy's name, FEIN, and DUNS number shall all remain the same. XOOM Energy shall maintain its principal business address, key contacts until such time that NRG notifies the Commission of any changes.
- 4. An updated list of the NRG retail affiliates' license numbers and the utility service territories where they are active is provided in Attachment A.
- 5. An updated list of the XOOM Energy's corporate officers is provided in Attachment B.
- 6. An update to the organizational structure of the NRG retail affiliates is provided in Attachment C.
- 7. Confidential Attachment D includes a Letter of Credit (SB-44529) to satisfy the Commission's financial security requirements for XOOM Energy Pennsylvania, LLC. NRG requests that the Commission return the Original Letter of Credit with all Amendments, accompanied by an original signed letter on the Commission's letterhead consenting to the cancellation of the prior Letter of Credit IS0501034U to Wells Fargo at the address listed below. To facilitate that communication, Attachment E includes a template for Cancellation of the Letter of Credit.



AND THE RULES AND REGULATION OF THE PENNSYLVANIA PUBLIC UTILITY COMMISSION BY THE PRINCIPAL AS A LICENSED ELECTRIC GENERATION SUPPLIER; TO ENSURE THE PAYMENT OF GROSS RECEIPTS TAX AS REQUIRED BY SECTION 2810 OF THE PUBLIC UTILITY CODE, 66 PA. C.S. 2810; TO ENSURE THE PAYMENT OF ANNUAL FEES AS AUTHORIZED BY ACT 155 OF 2014; TO ADHERE TO THE REQUIREMENTS OF THE ALTERNATIVE ENERGY PORTFOLIO STANDARDS ACT, 73 P.S. § 1648.1 ET SEQ. EACH DRAFT MUST BE MARKED TO INCLUDE THE SURETY NAME, SURETY LOCATION, AND LETTER OF CREDIT NUMBER.
