

**INSPIRE ENERGY HOLDINGS, LLC's
AMENDED CERTIFICATE OF SATISFACTION OF
COMPLAINT**


Inspire Energy Holdings, LLC (“Inspire” or “Respondent”) submits this Amended Certificate of Satisfaction pursuant to 52 Pa. Code § 5.24(b)(1), stating that the Complaint of Robert Schroeder c/o George McClay (“Complainant”) against Inspire has been satisfied.

On July 12, 2018, Inspire spoke with Mr. McClay to further discuss his concerns and the basis for the Disagreement with Satisfaction — received by the Public Utility Commission (“Commission”) on June 11, 2018. Mr. McClay maintains that a formal process should be established by the Commission through which vulnerable residents can be placed on a do-not-solicit list, so as to bar regulated entities from marketing to individuals who may lack the resources to make informed switching decisions. Mr. McClay further believes that the Commission should create a mechanism by which certain accounts are locked and cannot be switched according to the usual enrollment process. These concerns remain unresolved.

Without limiting or diminishing Mr. McClay’s positions outlined above, Mr. McClay has acknowledged to Inspire that he no longer wishes to pursue the Complaint against Inspire, and

that his ongoing issues are directed at the Commission. Consequently, the Commission should mark this complaint against Inspire as withdrawn in accordance with 52 Pa. Code § 5.24(c) unless Complainant objects within ten (10) days of this filing.


