This letter is a formal written correspondence on Docket No. C-2017-2630792, which is a complaint that I filed against PECO on October 15, 2017. On March 22, 2018, I emailed PECO indicating that I wanted to withdraw my complaint. This withdrawal request, which the P.U.C. has granted, however, was written after I had substantive conversations with a PECO representative on or about the March 22, 2018 date. During this conversation, it was promised by PECO that I would be granted a payment plan and that I should write a request to cancel the March 23, 2018 hearing. Subsequent to this conversation with the PECO representative, but after I had requested the withdrawal, I was told that I would not be the beneficiary of said payment plan.

For this reason, I am now informing the Commission that I would like to reinstate my claims in the original October 15, 2017 complaint. Absent the promise from the PECO representative on or about March 22, 2018, I would not have sought a withdrawal request and only did so because I was induced by a flagrant misrepresentation by the PECO representative.

Put formally, as directed by your June 25, 2018 letter informing me of the decision to grant the petition to withdraw the complaint, I do not agree with this decision and would like to proceed with the case as originally filed.
