



**I. INTRODUCTION**

1. By this Order, the Public Service Commission of the District of Columbia (“Commission”) grants a license to Bradley R. Lewis d/b/a CreativEnergy Options (“CreativEnergy” or “Applicant”) to function as an electricity supplier in the District of Columbia.<sup>1</sup> The license for Bradley R. Lewis d/b/a CreativEnergy Options is effective upon issuance of this Order.

**II. BACKGROUND**

2. On May 6, 2014, CreativEnergy filed its license application.<sup>2</sup> Specifically, CreativEnergy intends to operate as a broker of electricity for residential, commercial and industrial customers in the District of Columbia, pursuant to Section 34-1505 of the “Retail Electric Competition and Consumer Protection Act of 1999 (“Act”).<sup>3</sup> Pursuant to the Commission’s licensing requirements as set forth in Order No. 11796,<sup>4</sup> CreativEnergy has provided the following information:

- a) Proof of technical and managerial competence;
- b) An affidavit of compliance with applicable Federal and District of Columbia environmental laws and regulations dated April 19, 2014;

- c) Proof of financial integrity to include financial statements;
- d) Proof that CreativEnergy has registered with the Department of Consumer and Regulatory Affairs to do business in the District of Columbia;
- e) An affidavit dated April 19, 2014, stating that CreativEnergy is subject to all applicable taxes;
- f) An affidavit dated April 19, 2014, stating that CreativEnergy will comply with all the requirements of all orders and regulations of the Commission; and

CreativEnergy filed supplemental financial information on June 12 and July 16, 2014.<sup>5</sup>

### III. DISCUSSION

3.
