

COMMERCIAL AFFIDAVIT OF TRUTH

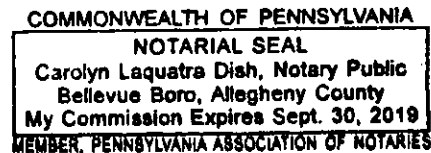
