Re: Seneca Resources Corporation Name Change to "Seneca Resources Company, LLC"

Dear Ms. Hess:

Seneca Resources Corporation is a Pennsylvania corporation. Effective July 1, 2015, Pennsylvania enacted a Conversion statute, 15 Pa.C.S. § 351, et. seq., providing a mechanism for Pennsylvania entities to convert to a different form of entity, e.g., converting from a corporation to a limited liability company. Section 356(a) of the statute provides that when a conversion becomes effective, the converted association is (i) "organized under and subject to the organic law of the converted association"; (ii) "the same association without interruption as the converting association"; and (iii) "deemed to have commenced its existence on the date the converting association commenced its existence in the jurisdiction in which the converting association was first created, incorporated, formed or otherwise came into existence..." Further, all property, liens, rights, debts, obligations and other liabilities of the converting association continue under the new entity without need of any legal transfer, assignment, assumption or other agreement. The conversion also does not give rise to any rights a third party might have upon a "transfer of assets, merger, dissolution, liquidation or winding up of the converting association..."

Pursuant to this statute, Seneca converted to a Pennsylvania limited liability company effective August 1, 2018. Seneca's new name is "Seneca Resources Company, LLC." The conversion did not result in a change to our state and federal tax identification numbers. A copy of our certified statement of conversion issued by the Pennsylvania Department of State is enclosed. Accordingly, please adjust your internal records to account for this name change. If you have a unique form that is needed for your records to document this change, please send a copy of the form to me or direct me to the web address where I can download it.


