Pennsylvania Public Utility Commission,

I am writing this response in regards to the docket referenced above to address the late filing of insurance coverage for Tri-Trucking LLC.

After many years with National Interstate Insurance Company we made a business decision to change our insurance carrier to Liberty Mutual Insurance Company. This decision was made prior to the insurance expiration date of June 1, 2018. Certificates of Insurance were mailed in advance of the expiration to all of our current certificate holders.

When your original notice signed June 16, 2018 was received, it was sent to our agent to comply. The original Certificate of Insurance to the Pennsylvania Public Utility Commission was in the originals sent out.

We did not know until yesterday afternoon when a voicemail message was received from Kathy Royer from enforcement that we were still not in compliance. We immediately contacted our insurance agent McGriff, Siebels and Williams and they contacted the carrier, Liberty Mutual Insurance. The insurance information needed was then overnighted today to the Pennsylvania Public Utility Commission.

If you check our previous record, we have been in compliance with the insurance requirements to the Pennsylvania Public Utility Commission in the past until this change of carriers.
