## Notice to Prevent Trespasses

i, woman; debra zimmerman, believe you, Elizabeth Barnes are woman; and i, believe that at times you act, as an Administrative Legal Judge for the Commonwealth of Pennsylvania;

i, say i, perceive from your correspondences "Initial Decision" and "Secretarial Letter" from August 16th, two thousand and eighteen, that you believe that i, am operating in your jurisdiction; and i, say i, wish and require to correct the record that i, operate as a woman;

i, say i, write this correspondence to bring remedy and to clarify for the record that i, operate as a woman, and i, do not require any decision, order, or ruling from you, Elizabeth as i, would consider it a trespass by way of harm;

i, say i, wish and require to reiterate for the record that i, am not making a "complaint" and i, am not a "complainant; i, say, i will be present as a woman to press a claim when necessary;

i, say i, give notice as a courtesy to you, the woman: Elizabeth Barnes; and to the woman: Gladys Brown; who i, believe at times acts as Chairman of the Pennsylvania Public Utility Commission, and to the woman: Rosemary Chiavetta; who i, believe at times acts as Secretary of the Pennsylvania Public Utility Commission, and to the man: Andrew Place; who i, believe at times acts as Vice Chairman of the Pennsylvania Public Utility Commission, and to the man: Norman Kennard; who i, believe at times acts as Commissioner of the Pennsylvania Public Utility Commission, and to the man: David Sweet; who i, believe at times acts as Commissioner of the Pennsylvania Public Utility Commission, and to the man: John Coleman Jr.; who i, believe at times acts as Commissioner of the Pennsylvania Public Utility Commission, to prevent a trespass by way of harm by any man or woman against i;

I, say i, am not accepting any actions or attempts to deploy or carry out any decisions, orders, or rulings by way of installing the device "smart meter" and or its components, including but not limited to the so named "smart meters," "advanced meters," "Smart Grid," non-transmitting digital meters and or related technologies with capabilities of emitting microwave frequencies and or transmitting detailed data of in-home activities relating to the consumption of electrical, and or water, and or gas (components collectively referred to as (Trespassing Technology)), and will see such action or deployment as trespass by way of harm;

i, say i, consider any actions or attempts to deploy or carry out any decisions, orders, or rulings by way of installing the device "smart meter" and or its components a trespass by way of physical and mental and emotional harm, injury, and financial loss; and i, will seek compensation for any and all trespasses;

i, say if the electricity is no longer delivered or turned off, at the property i, claim (at or near 2610 Gateway Drive, Harrisburg, Pennsylvania), for not wishing the use of "smart meter"/"trespassing technology" device i, will require compensation, for any financial losses and or harm and i, say, it is not the wish of i, to be charged an extra fee as a penalty; for to not allow "said" device on "said" property; as i, would consider it a trespass by way of extortion;

i, say if any man or woman, does install a smart meter device on said property of i, without the consent of i; i, will then consider it a trespass by way of harm and pain and loss and will seek compensation, of, ten million dollars (\$10,000,000) per trespass and one million dollars (\$1,000,000) per day that said device remains on said property; and i, will press all claims in front of a trial by jury;
