

Dear Ms. Chiavetta,

I am writing in response to a complaint filed against me for failure to maintain evidence of Cargo Insurance on file with the Commission. Upon receipt of this complaint I forwarded a copy to my insurance agent and requested they check into why this complaint was being issued. It was my understanding all the necessary filings were done and issued on time as per an email I received July 17, 2018 confirming such. On August 6, 2018 I received an email from the agency reassuring the filings were made on time and they reached out to someone at the PA PUC. I was advised to email a letter and proof of insurance to Mr. Swindler regarding this matter and I did so. On August 7, 2018 a Notice to Lift Suspension letter was issued and I assumed all was resolved.

Today I responded to a phone call from Ms. Royer and it was explained to me even though the suspension was lifted a letter of explanation is required. It was a misunderstanding on my part for not fully complying with the terms of the complaint. I have enclosed copies of several pieces of correspondence as evidence to support my statements and why I was under the impression all issues were resolved. Please accept my apology and waive any fines or penalties with regards to this complaint.
