
Dear Judge Watson:

I need to make a request about the upcoming timing on my case, **Docket #: C-2018-3003324**.

- **Background:** When I first received a letter that Met-Ed planned to install a smart meter, I called the company and asked to opt out. I was told that no opt out was available. I explained that I had to opt out for health reasons, and was told to file a formal complaint. I filled out the required paperwork, which was a simple form filled in by hand, and mailed it to PUC. I did not realize that a legal case had been initiated.
- Since then, I have taken each required step, guided in part by Lauren Lepkoski, attorney for FirstEnergy, who was very helpful.
- Now I need to ask for a pause in the process, for professional reasons. I called PUC's legal department to ask how to do this, and they advised me to submit this request to you.
- Here is the situation: I am an international teacher (please see the list of past teachings that follows this letter). I have a teaching trip coming up soon. This trip was arranged eight (8) months ago.
- I need at least a month to prepare for such a teaching trip; I am already behind in these preparations. Then I will be on the trip for three weeks; there is not a moment of free time on these teaching trips for anything other than the matters at hand. Then I will need another month when I return, to get over jet lag, do follow-up with students and organizers, and get my business back on track.
- Therefore, I respectfully request that this legal process resume on December 15, 2018. That would be the date when I could enter the legal process again. Please let me restate for clarity's sake: This is not a date by which I could meet a new legal deadline. It is a date by which I could begin to address whatever is required next in the legal process.
- I have been trying to speak with Lauren Lepkoski, attorney for FirstEnergy, to ask if she agrees with this timeframe. I set up two appointments to talk with her by phone, but she was not in her office either time. Her assistant kindly apologized. I called her again yesterday and she was not available. I understand that she is very busy. I hope she will understand the compelling nature of this situation.

I very much want to complete the legal process we are in. But I cannot continue further until December 15, at which time I could begin to address whatever is next in this legal process. I respectfully ask you to grant this request.
