On October 4, 2018, the Commission received your Application for Motor Common Carrier or Property Authority of OHT Inc dba OHT Transport. Upon initial review, the application has been found to need clarification or correction

\* The 1st page of the application needs to be corrected. The legal name of the Company needs to go on line one. A fictitious name, (d/b/a) if any, should go on line two. The name OHT Inc. is registered as a company. If this is your corporate name then it should go on line one. If you wish OHT Transport to be your company's trade name, then it will need to be registered with the Pennsylvania Department of State as a fictitious name. Once it is registered it should be placed on line two. You may also choose not to use a fictitious name and leave line 2 blank.

\* Page 2 of the application is missing from the filing. This page contains questions 5-9 and must be answered before the application can be processed.

Pursuant to 52 Pa. Code §1.4, you are required to correct these item. Failure to do so within 20 days of the date of this letter will result in the Application being returned unfiled.

You may return your corrected application by mail or by you may e-file it. Please do not pay the filing fee again It has already been paid.
