**This is the typed version of Pg.5 Requested Relief.**

Me. Pinney had contacted me prior to this matter (the PGW reversal of account) with request to add her mother to the lease. When questioned why – she had stated it was in order to avoid paying “excessive” gas bill charges etc. I refused.

Soon after I learned that Ms .Pinney contacted PGW with a complaint that washer and dryer in basement (only dryer is gas operated) are connected to her gas meter only.

PGW went out to the site and confirmed this. Without further notice soon after the (entire) bill was reverted to my name (landlord). The bill had contained over \$1600 of prior unpaid gas charges already at the time. PGW were contacted. PGW refused assistance stating I must file PUC complaint. The washer and dryer in question, however, have not had power to them for many months and as such are inoperable. The entire tenant story and complaint is based on no fact of any gas losses and has absolutely no merit. It is nothing but a scheme devised by the tenant to avoid payment of her gas bill.

Therefore, I respectfully request the billing and al charges to be reverted back into tenant’s name. (Gas I a full responsibility of the tenant by lease)


I would like to adu that it is appalling that a public utility would be so easily fooled and as such conspire with tenant to defraud their landlord.


