

**TO ADMINISTRATIVE LAW JUDGE ELIZABETH H. BARNES:**

Pursuant to Section 5.103 of the Pennsylvania Public Utility Commission’s (“Commission”) regulations, 52 Pa. Code § 5.103, and Rule 301(b) of the Pennsylvania Bar Admission Rules, Counsel of Record for PPL Electric Utilities Corporation (“PPL Electric” or the “Company”), Devin T. Ryan, Esq., respectfully requests that Your Honor enter an Order granting admission *pro hac vice* to Curtis S. 


