

As directed and in conformance with the Public Utility Commission Letter dated September 02, 2018 in reference to PUC A-8911693, please be advised that there was not a lapse in coverage with regards to the Commercial Auto Liability or Cargo Insurance Coverage (See attached Declaration Page). Upon receipt of the PUC Letter dated September 2, 2018, I contacted my Insurance Agent on September 3, 2018 in order to resolve the issue. He indicated that the Filings were rejected by the PUC for an inaccurate Named Insured on the submitted Insurance Policy/ Filings. The name of the Business is scheduled with the State as Steve's General Delivery Service, LLC. PennDOT has a different name identified as Steve's General Delivery Services, LLC.
