RE: Keary Willis, Updated Disability Status

To Whom It May Concern,

As a result of a ruptured Aneurysm, Keary Willis has been under my direct inpatient medical care since receiving Aneurysm Clipping and Craniotomy. During the surgical procedure this patient suffered a cerebrovascular accident (minor stroke), further complicating healing. Our patient's inpatient and rehabilitation has progressed as expected since the surgical interventions and hemorrhage. However, rehabilitation and inpatient stay is still ongoing. This patient is not expected to be medically discharged from care before November 20, 2018. The patient will not be available for any unassisted traveling before November 30, 2018.

We expect a full-recovery, however, this patient will not be medically released before November 20, 2018. It is with the utmost degree of medical certainty this patient should engage in any activities prior to November 30, 2018. We strongly encourage any appointments etc., be rescheduled at that time.
