

1. An in-person hearing for this matter is currently scheduled to take place on Thursday, December 13, 2018 at 10:00 a.m.
2. The Complainant alleges in his formal complaint that a power surge damaged equipment in his home.
3. The Complainant requests reimbursement for his equipment.
4. At the hearing, PECO will present the testimony of Senior Claims Case Manager, Timothy Grow, who investigated and handled the Complainant's claim.
5. Mr. Grow is unavailable on December 13, 2018, as he is already scheduled for a deposition in a civil case.


