LifeEnergy, LLC (“LifeEnergy”) files this Certificate of Satisfaction pursuant to 52 Pa. Code § 5.24(b). LifeEnergy believes that it has fully satisfied the Formal Complaint filed by Ms. Veronica Journick in the above-captioned proceeding. In her Formal Complaint, Ms. Journick disputed her enrollment with LifeEnergy and requested that her account be cancelled without penalty. LifeEnergy maintains that Ms. Journick authorized the switch and that her enrollment was valid.
